ABOUT LEAP

LEAP was established in 1992 to advance racial equity by providing free social and academic enrichment, mentorship, and leadership opportunities for children and teens in New Haven's low-income neighborhoods. In addition to a focus on literacy and phonics, LEAP provides children opportunities in art, swimming, camping, cooking, team building, and more. As the largest employer of youth in New Haven, LEAP trains high school and college students as mentors to the children while also expanding their college and career options. LEAP provides year-round programming at eight community-based sites, including the Roslyn Milstein Meyer LEAP Community Center in Wooster Square and the Dixwell Community "Q" House.

In 2024, LEAP worked with more than 1,300 children, employed over 300 young people, continued our phonics program, hired six summer social workers, expanded out-of-New Haven experiences for teens, offered overnight camping to all children, and bolstered college access with more free college tours and an academic success coordinator to assist with college and financial aid applications.
